("BP"). He is responsible for the management and origination of long-term business in the gas and LNG markets as well as leveraging BP's integrated trading offer across the oil and gas industry. He has joined BP since June 2006.</p> <p>The Nominating Committee met with Mr. Felipe and assessed his suitability in complementing the core competencies of the Board taking into consideration relevant evaluation criteria in the Internal Guidelines of the Company for the selection and appointment of Directors, which include his background and working experience, industry knowledge, professional skills and qualifications.</p> <p>Mr. Felipe has extensive experience in the oil and gas industry, across upstream, processing and downstream operations.
